I. PRINCIPAL INFORMATION

II. GRANT OF AUTHORITY

I grant my Agent the authority to act on my behalf for the following purposes related to the items of interest (Items) delivery:

1. To receive and accept delivery of items on my behalf.
2. To inspect the items of interest upon delivery to ensure it meets the agreed specifications.
3. To sign any documents necessary to accept delivery of the items, including but not limited to delivery receipts and acceptance forms.
4. To communicate with the merchant delivery company regarding scheduling, changes, or issues related to the delivery of the furniture.

III. DURATION OF POWER OF ATTORNEY

This Power of Attorney shall be effective immediately and shall remain in effect until the delivery of the items is completed or until revoked in writing by the client within 48 hours of the intended delivery date.

IV. INDEMNIFICATION

I hereby agree to indemnify and hold harmless my Agent from any claims, liabilities, or damages arising from their actions taken in good faith under this Power of Attorney.

V. GOVERNING LAW

This Power of Attorney shall be governed by and construed in accordance with the laws of the State of Texas.

VI. KEYHOLDER AGREEMENT (If Applicable)

This Keyholder Agreement ("Agreement") is made as of [Date], by and between [Customer Name] ("Customer") and Greenlight (Keyholder).

1. Purpose

The purpose of this Agreement is to outline the terms under which the Customer will provide the Delivery Company access to their premises for the delivery of furniture.

2. Access To Property

The Customer agrees to provide the Delivery Company with a key or access code to enter the property located at [Customer's Address] ("Property") for the purpose of delivering furniture.

3. Delivery Schedule
